RE: RECENT MEDIA COVERAGE: NON-PAYMENT OF RAF MEDICO LEGAL EXPERTS

The above has reference.

There has been a flurry of media activity in the last few days, the contents of which are immensely concerning to SAMLA as well as its members.

There appears to have been claims in the media that the RAF has denied liability for the cost of medico legal reports prepared by experts at the instance and request of the RAF's panel attorneys — this during a time when such attorneys were mandated to act on behalf of the RAF.

Before we address our members, it is crucial that we have an understanding of exactly what the RAF's position is in relation to the outstanding accounts of its medico legal experts.
