Re: Recognizing a Professional Body and Registering a Professional Designation for the Purposes of the National Qualifications Framework Act, Act 67 of 2008

(as amended, March 2018)

- This letter serves as an application from the South African Medico-Legal
   Association (SAMLA), to attend a SAQA compulsory workshop for prospective professional bodies.
- 2. SAMLA is an independent public benefit organisation, which seeks to promote mutual understanding, as well as a high standard of ethical and competent practice by professionals in the large number of disciplines involved in medicolegal practice. The South African Medico-Legal Society (SAMLS) was formed in the year 2000. At its AGM in November 2015 the name of the South African Medico-Legal Society was changed to the South African Medico-Legal Association. SAMLA now has branches in Gauteng, Western Cape, KwaZulu-Natal, Free State and Eastern Cape. SAMLA members, and medico-legal practitioners in general, include legal practitioners, medical practitioners, allied healthcare practitioners and others such as actuaries, mediators, architects and case managers. In the pursuit of its public benefit goals, SAMLA has engaged constructively with a large number of other stakeholder organisations, and has built mutually respectful relationships with such organisations. These include medical-, legal- and other professional organisations, universities, mediation training organisations and various organs of state. - 4. In the pursuit of its educational goals since 2000, SAMLS/SAMLA has presented regular medico-legal seminars, workshops and mock trials. More recently SAMLA, in partnership with UCT Law@work, has developed and presented more formal and structured postgraduate training courses in medico-legal practice, aimed at practitioners in all relevant disciplines. Feedback from participants in these courses has been most positive, in the sense of empowering practitioners to better understand their role and to improve their levels of ethical/competent practice and self-confidence. This program, which utilises multiple site education with electronic simulcast in order to reach participants across the country, is now in the second year of a three-year programme. SAMLA is also in conversation with Prof Ranavaya of ABIME (American Board of Independent Medical Examiners), who has proposed ABIME/SAMLA collaboration and cross accreditation in the presentation of medico-legal training courses in South Africa. We have had preliminary discussions and have agreed in principle on the manner in which the expertise of ABIME and the expertise of SAMLA will complement one another, and further discussions are scheduled for September 2019. - 6. We are aware that time, effort, study and money by practitioners will not convert into qualifications on their own. The goal of the above progression is to develop an accredited structured curriculum that will meet the required standards of SAQA, HEQC, NQF, etc. so that study time and effort by practitioners will be converted into qualifications.
- 7. Over the years there have been numerous requests by stakeholders for SAMLA to establish a register of accredited medico-legal practitioners. SAMLA has explored relevant practicalities and criteria in this regard, but although it has the expertise, it does not yet have the authority to establish such a register. As a service to the emerging professional field of medical mediation, SAMLA has developed a Guidelines and Protocol for Medical Mediation, planned and commenced Pilot Projects in Medical Mediation, and developed a Register of SAMLA Verified Medical Mediators. We are of the sincere belief that SAQA recognition of SAMLA as a professional body, as well as approval for registering professional designations, will be of great national benefit in attracting larger numbers of practitioners to relevant educational programs; in elevating the standard of medico-legal practice; and in bringing order to this troubled field. - 9. For these reasons we respectfully urge you to consider our application favourably and to invite SAMLA to the requisite workshop.
