SAMLA Annual AGM meeting - 21 November 2023

It is time for the election of a new board. SAMLA's annual AGM meeting is taking place on the 21 November 2023 and a new Board must be chosen. ### **RAF** challenges:



SAMLA has withdrawn from the RAF challenges group but will avail their services when this group requires assistance. The Department of Transport has published the Road Accident Fund Amendment Draft Bill 2023 for public comment in Government Gazette 49283 on 8 September 2023. The Bill removes the right to claim compensation and replaces it with a purported social benefit that is in fact simply a drastic limitation of compensation, and is inferior and in no reasonable and rational way comparable to the right to compensation currently enjoyed by road accident victims.

The current system of compensation adequately provides for the needs of road accident victims and there is no reasonable basis for the stripping away of the rights to compensation proposed in the Bill.

SAMLA has supported the RAF challenging group about submitting comments on the amendment RAF Act.

Dr Edeling received an invitation from the RAF EXCO committee regarding mediation, however, the meeting was cancelled by the RAF on short notice. We are waiting for the next date with the RAF Management regarding future mediation with SAMLA.
