# WHAT DOES SAMLA, WESTERN CAPE HAVE ON THE CARDS FOR 2018?

The South African Litigation climate is precarious these days to say the least. We are in a transition period between classic: "yes, I have sued you and I will see you in Court" vs "I believe X is your client, I have evidence that he did Y, can we schedule a meeting to discuss the way forward...".

SAMLA's main focus is one of education and talking about change and effect. The topic pool is vast and deep and we accordingly want to try something new to appease as many member's interests and needs as possible:

We are inviting you to join us every 8 - 12 weeks for an evening of discussion and debate; then, in August we will have a 2-3 day formal seminar/workshop on one subject. This year the focus will be on **Case Management**. This is a new buzz word among lawyers and medical practitioners/experts. The workshop will explore:

- 1. The "definition" of a Case Manager (CM).
- 2. How has the need for CMs evolved in the medico-legal industry over time, and what are the current trends of practice?
- 3. Considerations when appointing a CM:
  - a. Identifying **when** a CM should be appointed i.e. for what reason and what sort of cases? Should a CM be appointed by patient's attorney straight away so that a proper account of what should be claimed, quantum wise, can be assessed?
  - b. The qualifications, experience and geographical location of the CM.
  - c. **Roles**, functions and activities of the CM, including boundary setting and ensuring that there is no conflict of interest.
  - d. Required hours of service over time, fees, travel expenses, contract requirements, etc.
- 4. Components of the CM duty: including the identification of needs, developing the case management plan, implementation and co-ordination of care activities, evaluation and follow-up, termination of the CM process etc.
- 5. CM's who know the patient and his/her family are vital when a Trust/ Curator *Bonis* is appointed;

- 6. Establishing a society of CM's?
- 7. Discussion regarding the development of:
  - a. A protocol/guideline for medico-legal CM's;
  - b. Training for medico-legal CM's;
  - c. A consortium / network of suitably qualified medico-legal CM's.


