Important information:

- Registrations open on Tuesday 18 December 2018.
- Once we have received your completed registration forms, we will forward you an invoice. The invoice will contain the bank details and a payment reference number which you must use when effecting payment.
- Certificates and CPD letters will be issued in the name of the participant as supplied on the application form.
- Practitioners registered with HPCSA will earn CPD points for each workshop attended. CPD letters indicating the awarded points will be issued by UCT. (SAMLMA has no influence on the number of CPD points awarded by the HPCSA).
- Participants who attend both (or all 3) lecture days of a workshop, attend and participate meaningfully in syndicate meetings, and complete a satisfactory assignment report, will receive a Certificate of Successful Completion of the training workshop.
- Participants who attend both (or all 3) lecture days of a workshop, and attend syndicate meetings, but fail to complete a satisfactory assignment report, will receive a Certificate of Attendance of the training workshop.
- Participants who obtain Certificates of Successful Completion for each of the first 3 workshops in 2019 will be awarded an Umbrella SAMLMA Certificate of Competence in Writing RAF4 Narrative Test Reports.
- Participants who obtain Certificates of Successful Completion for each of the 5 workshops in 2019, will be awarded an Umbrella SAMLMA Certificate of Successful Completion of the 2019 Series of Practical Training Workshops in Medico-Legal Practice.
- In order for participants to enroll for the 3rd year series of workshops in 2020, they will need to have successfully completed the 2018 Foundations Course in Medico-Legal Practice (or the equivalent online e-course) and complete all 5 workshops of 2019.
- Participants who obtain Certificates of Successful Completion for each of the 10 workshops in 2019 and 2020, will be awarded an Umbrella SAMLMA Certificate of Competence in Medico-Legal Practice.
