Four board meetings and one special board meeting were held since the last AGM in December 2021.



8 EXECUTIVE COMMITTEE MEETINGS

Six executive and one special executive meeting were held during 2022.

9 BOSBERAAD 2021

Resolutions decided upon at the Bosberaad held in May 2022

- SAMLA will develop a Code of Conduct for Board directors, which will also be applicable to Honorary Life Members and the Non-Executive President. A separate code of conduct for honorary members and a specific code of conduct for board directors were developed. These codes were approved by the Board.
- 2. An education and training committee was to be established that will include all educational offerings by SAMLA including Faculty, Provincial Branches, Special Interest groups, SAMLA central. The education and training committee was established and was chaired by Stacey Aires. The resolutions taken at the Bosberaad were implemented and were evaluated. However, changes to the E & T committee were made namely that the Credentialing and CPD no longer formed part of the E &T Committee. It was felt that the E & T committee were confronted with too many activities. The board approved the change.
- 3. Administration support to be appointed.

A proposal for the appointment of an admin coordinator was formulated and admin support was appointed.

10 STRATEGIC PLANNING COMMITTEE 2022

A strategic planning committee was held on the 12 November facilitated by Dr Brad Beira. **Three strategic steps** were taken at this meeting for 2023 namely,

1 Managing the Board: induction and Board skills development and training for all Directors



- 2 Communication and Education strategies: To continue with workshops and fireside talks. Refining curriculi, identify faculty
- 3 Annual Conference arrangement to continue and Foundations Program to be redeveloped

11 COMPLYING WITH THE COMPANY ACT 71 OF 2008

To ensure good governance by complying with the Companies Act, the SAMLA board and EXCO continued to monitor the activities of SAMLA according to the MOI to ensure good governance. Various activities are consolidated into smaller committees. I have highlighted some aspects from individual reports. The reports are available on the SAMLA website.

11.1 MEDIATION COMMITTEE

11.1.1 Pilot study

Under the chairmanship of Dr Trevor Frankish the committee showed much success. The pilot project of 100 RAF mediations came to an end and the original commitment of 25 pro bono mediations for the Gauteng Health Department has been exceeded (now about 29 cases). After reaching the goal set for the pilot study Dr Frankish indicated that a new chairman was required to continue the project. Attorney Danie Weideman agreed to continue but unfortunately due to work commitments had to resign. Mr Johan Venter has now taken up the chairperson's position of the mediation committee. Discussions with ECP are underway for a new pilot study to be started in the ECP. Activities in Gauteng to continue.

11.2 ROAD ACCIDENT FUND (RAF) COMMITTEE



11.2.1 New chairmanship

Attorney Leigh de Souza-Spagnoletti served as chairman of the committee and resigned after a year. Adv Maryke Pienaar agreed to take up this position.

11.2.2 RAF workshop

SAMLA participated in RAF Round Table Stakeholder discussion held on 1 March 2022

11.2.3 RAF pilot study in mediation

- SAMLA agreed to offer pro-bona 100 RAF cases applying mediation which was completed,
- SAMLA attended a court stakeholder committee meeting chaired by Honorable Justice Mlambo and attended by DJPs Sutherland and Ledwaba from both Gauteng Local and Gauteng Division. The Court appears eager to establish a mediation pilot project aimed at addressing the backlog of trials and reducing pressure on the trial roll allocation system. Support for such a project appeared variable with some attendees strongly in favour thereof with others either skeptical or opposed thereto.

11.3 BUSINESS DEVELOPMENT COMMITTEE

- The committee is chaired by Rowan Haarhoff.
- A learning management system (LMS) was explored for SAMLA members to access various recorded workshops. SAMLA will require a proper business plan before we commit to monthly obligations: Estimated cost per month is about R3000.
- The chairperson urged the various committees to increase the adoption of the Business Development Plan.
- The committee emphasised the introduction of a uniformed approach to running and marketing Online Provincial events to increase organisational clarity and consistency of message amongst members. A standard operating procedure was completed for this purpose.



- To create a calendar that can set out all the education and learning opportunities available to members throughout the year.
- Completed Sponsorship Policy

11.4 EDUCATION AND TRAINING

11.4.1 Certificates

All certificates for the Foundation Course and workshops were completed and sent to students. Certificates have both UCT & SAMLA logos displayed on it.

11.4.2 Education and Training committee

As decided at the Bosberaad an Education and Training committee should be introduced and this was implemented. The committee chaired for most of the year by Stacy Aires was successful in organizing and implementing the following:

11.5 FINANCIAL COMMITTEE

SAMLA has shown a positive financial balance for 2022. Details of the financial situation are captured in the Treasurer's report.

11.6 ADMINISTRATION AND QUALITY COMMITTEE

- Under the leadership of Renier Jacobs, the committee formulated a proposal for the appointment of an admin coordinator which was approved by the board. Currently 60 hours of admin support is available for admin activities and the education and training committee.
- The committee further ensured that SAMLA was compliant with CIPC requirements
- Designed a risk register approved by the Board.
- Facilitated the formulation of a Communication Committee.
- Facilitated a meeting with the auditors who identified shortcomings in how incoming funds from various sources are captured electronically. Under the leadership of Johan Jordaan (National treasurer), the problem was addressed with the support of the auditors.

11.7 COMMUNICATION COMMITTEE

- Anneka Greef led the communication committee which was formed during the course of the year.
- Anneke completed three SAMLA Newsletters sent to all our members and others.



- She ensures that our social media namely Face book, LinkedIn and SAMLA website are up to date.
- SAMLA was also interviewed by five radio stations and one television interview for discussions on the criminalization of healthcare professionals. Prof Lerm and the chairperson Prof Stellenberg represented SAMLA in this regard
- The communication policy was completed.
- I would like to acknowledge and thank our secretary Christa for managing all incoming and outgoing email communication. She is the link to the outside. In addition, Christa is our electoral officer who was responsible for the elections of new directors during the course of the year.

11.8 CREDENTIALING COMMITTEE

Guided by Prof Tabane as chairperson for the credentialing committee. Criteria for the various tiers are on the website and the membership is encouraged to apply for the more senior tiers should they meet the criteria. The following tiers are:

- i. Tier 1: Medico-Legal Practitioner
- ii. Tier 2: Advanced Medico-Legal Practitioner
- iii. Tier 3: Senior Medico-Legal Practitioner
- All members who completed the Foundations course successfully were automatically registered on the register for medico-legal practitioners.
- According to the recognition of prior learning (RPL) policy, members who have not completed the foundations course may apply for registration as a medicolegal practitioner by submitting a portfolio of evidence (POE) for evaluation by the credentialing committee.
- SAMLA members are urged to apply for registration as ML practitioners.
- Current registrations on the medico-legal practitioners register: 75 and mediation register: 110.



11.9 TRANSFORMATION COMMITTEE

Led by Dr Sharon Munyaka who continues to monitor that SAMLA portfolios include a component of transformation across all SAMLA activities e.g., conferences, updating policy, training activities, recruitment and selection of directors and representation of speakers across events to enable representation and diverse inputs across medico-legal professions

11.10 DISCIPLINARY COMMITTEE

- Led by Adv Johanni Barnardt the disciplinary policy was completed and approved by the board
- The committee received one complaint about a member for unethical practice. This was explored through a process and finally recommendations were made to the board.

11.11 INTEREST GROUPS

11.11.1 Quantification interest group

Under the leadership of Acting Chairperson Mr JP Venter. The committee was very active hosting eight (8) meetings.

Training activities:

- -Informal Sector Talk: Presented by Charles Maisel
- -Discussion of SIOPSA Professional Practice Guidelines for Industrial Psychologists: Presented by Natasha Gerber, Chair of SIOPSA Psycho Legal Interest Group.

Two members of the Q-Group initiated and contributed to a panel of 8 that wrote Guidelines for Industrial Psychologists in medico legal work. This was presented as a panel discussion on the Annual SIOPSA (IP Association) Conference.

The committee proudly indicates that they formed part of the key contributors towards SIOPSA's Professional Practice Guidelines for Industrial Psychologists.



11.12 PROVINCIAL ACTIVITIES

The new approach to offering SAMLA educational activities with the provinces taking the lead, created much excitement and networking. However, not all provinces assisted with the offering of educational activities which created unhappiness. It was thus decided that the offering of educational activities will be centralized, i.e. offering activities from a central level. Provinces may continue to network on a face-to-face level and to offer educational events on a national level. These events will be coordinated by the Educational and Training committee.

12 COLLABORATION ACTIVITIES

12.1 Medical Protection Society (MPS) (A Member Of The Medical Protection Society Limited Group Of Companies)

- 1. Kate Tullett Media Relations Manager of *The Conversation* invited SAMLA to write an article about the situation in South Africa regarding criminalization of healthcare professionals. Prof Lerm and the chairperson completed the article and this was published.
- 2. On the 23 November SAMLA was invited to participate in a round table conference held in Pretoria to continue the discussion about the criminalization of healthcare professionals and the way forward. The chairperson, Prof Stellenberg, Prof Lerm and Adv Johanni Branardt represented SAMLA via zoom. At the meeting Ms Ronel Van Zyl from the Law Reform Commission gave a talk about the process to follow to bring about any changes to legislation.
- The chairperson met with Dr Graham Howarth on Sunday 27th November 2022 for collaboration in the training of medico-legal experts and further collaboration about the criminalization of healthcare workers.



12.2. South African Institute of Medico Legal Experts (SAIME) SAMLA received an invitation from SAIME to collaborate on medico-legal matters. The board approved the invitation and a delegation from the executive committee was elected to meet with SAIME.

13 SALRC: INVITATION TO PARTICPATE IN A WORKSHOP ON MEDICAL CLAIMS

SAMLA received an invitation to provide input on the report on Medico-Legal Claims by the SALRC. Further to this SAMLA was invited to the Commission's office in Centurion to participate in a workshop on the *Discussion Paper 154 Project 141: Medico-Legal Claims* on the 8 March 2022. SAMLA was represented by the chairperson Prof Stellenberg, Prof Lerm and Adv Johanni Barnardt.

14 MEMORANDUM OF INCORPORATION (MOI) AMENDMENTS

Changes made to the MOI at the last AGM were implemented. However today the meeting will vote on additional changes to the MOI as approved by the last Board meeting. The **following requires approval:**

MOI amendments for approval:

"7.2.1.1 *the Chairperson of each Branch of the Company will be appointed exofficio to the Board of Directors".* The t**reasurer of the branches** will no longer be appointed to the Board of Directors.

"7.8.3 The term of office for the non-executive president will be two election periods i.e., four (4) years and who may be re-elected for another term of office" **New addition to the MOI**
